

In the 2016 presidential election, some electors chose not to follow their state's popular vote and case a different vote. The case went to the U.S. Supreme court for a decision. List all the sources of law that would be used by the court in deciding whether "faithless" electors could cast a vote different from what was

required under their state laws.

ANSWER:

The U.S. Constitution would be interpreted because it establishes the process for presidential elections. There would also be the rights of voters under the U.S. Constitution. There would be state laws because the states establish how they will determine how their electors will vote. In some states, there would be constitutional provisions that would also apply. There are also administrative regulations at both federal and state levels that would have procedural details on the electoral college. Finally, there would be precedent. The court would look at the previous court decisions on issues related to presidential elections. There are both substantive rights and laws as well as procedural laws involved in the decision.

In *Chiafolo v. Washington*, 140 S. Ct. 2318 (2020), the court held in a 9-0 decision that there could not be "faithless" electors. They are required to vote according to the processes established for their selection in their states. The court held that allowing electors to not follow those rules would undermine the results of the election and the voting rights of citizens.
