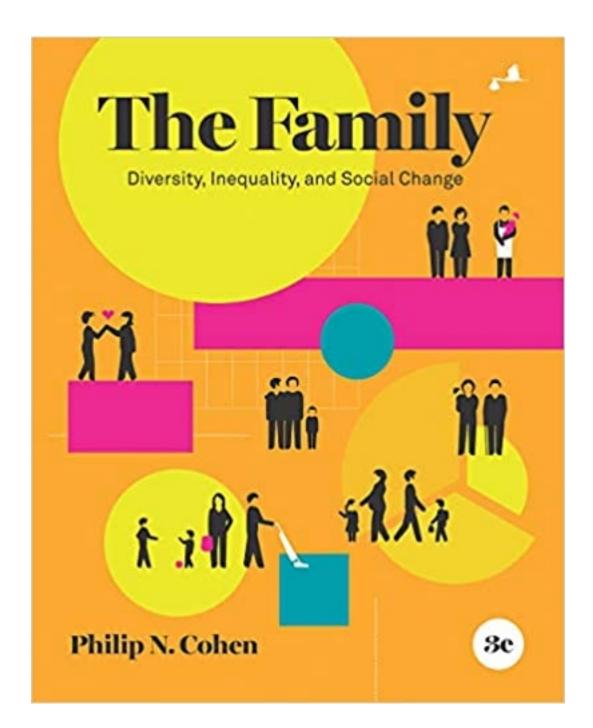

The legal definition of family includes only people who are related by birth, marriage, or adoption, and the dominant family ideal continues to be an image of a married woman and man and their two biological children (and possibly a dog). Most people's families do not look like this ideal. Individuals often have a fairly broad definition of family, which may be a "personal" definition that includes people who are not related by "blood" or marriage, yet they may also provide a more standard image when asked to draw a family.
82.	Answer:	Answers will vary. The legal definition of family is a group of individuals related by birth, marriage, or adoption. For the census, this group must reside in the same household. This definition is important for the legal benefits and responsibilities that the government provides and imposes on families.
83.	Answer:	Answers will vary. Examples include the fact that the state determines who is allowed to marry and form a family. Families purchase child care in the marketplace, and our jobs in the paid labor force influence the time we spend with our families, our relationships within them, and what we are able to provide.
84.	Answer:	Possible answers include using DNA testing to determine biological family ties, mapping family trees to look for family ties using historical records, and trying to find a tie to a long-lost family member for legal reasons, such as

inheritance.

85. Answer:

Biological family members include anyone you know about who is related to you by DNA. However, we often refer to others as "family," including folks who are completely unrelated in a biological sense but to whom we feel a strong connection and consider part of our family.

86. Answer:

Much resistance to same-sex marriage and same-sex parented families appears to come from those who view marriage as connected to religious views and rules that emanate from an authoritative source. There does not appear to be the same type of resistance from those who view marriage as a legal status subject to changing interpretations and regulations.

87. Answer:

Teachers can use corporal punishment because they are seen as an extension of parental authority. Arguments against this practice might include that families feel their own disciplinary approaches are privileged, and that they have not given individual teachers the symbolic role of family extension.

88. Answer:

The personal family allows for a broader definition of the family that focuses on whom we feel related to, while the legal family is that which is recognized by the state or governing bodies. The family as an institution refers to the broader space in which relations take place. The institutional arena contains elements of the legal family.

89. Answer:

Institutions have facilitated changes, such as the census changing the definition of family, and families themselves have changed, such that stepfamily members are now recognized in both a legal and cultural sense.

90. Answer:

The structural functionalist approach is part of the consensus perspective, and therefore focuses on stability rather than change. Structural functionalists specifically focus on the function of common behavioral patterns. Conflict theorists, however, focus on the role of conflict and opposition. Structural functionalists focus on the harmony and consensus that occurs in society, and conflict theorists focus on opposition. Structural functionalists view the breadwinner-homemaker family as instrumental to family harmony. Men and women each perform a separate, but necessary function; this creates a balance and mutual dependence. Conflict theorists would argue that the breadwinner-homemaker model is linked to exploitation and capitalism. According to cultural theorists, this model grew because it allowed employers to pay husbands less when their wives were doing all unpaid labor at home.

91. Answer:

Some examples include the focus on the importance of socialization, understanding inequalities among and between families, the importance of viewing families as socially constructed, and beliefs about appropriate gender behavior are not uniform across people.

92. Answer:

Changes in the definition of family and understandings about family structure have coincided with the emergence and evolution of sociological theory about families. These theoretical approaches have provided sociologists with tools and approaches for making sense of families, including changes in family structure, cultural influences in the definitions of families, and the increasing role of the state and market in determining family relations.

93. Answer:

Sociologists avoid bias by relying on large, publicly funded, nationally representative studies. They also rely heavily on peer review.
