

#### **GLOSSARY**

#### Instructor's Note

Consider using selected definitions listed below for matching questions on a quiz or exam. These are important terms the student should be able to define and are outlined more fully in the chapter.

*Allied health care workers* Professionals involved in health care delivery to the individual, group, family, or community that is the focus of intervention.

*Clinical social work practice* Often referred to as medical social work (see *medical social work*).

*Family counseling* A practice methodology that centers on the "family" as the patient/client/consumer or unit of attention.

*Health care practice* The activities that are conducted that are designed to enhance physical and psychological well-being.

**Health care social work** The practice of social work that deals with the aspects of general health, specifically in the areas of wellness, illness, or disability. The social work professional can address these issues through working directly with either individuals, groups, families, or communities, or through the auspice of broader social change.

*Health care social worker* Seen as the professional "bridge" that links the patient/client/consumer, the multidisciplinary or interdisciplinary team, and the environment.

*Hospital social work* Historically defined as the provision of social services in a medical setting. Currently, refers to the delivery of social work services in hospitals and related health care facilities.

*Market assisters* These are trained lay individuals who are paid to assist patients/clients/consumers in the enrollment process determining Affordable Care Act (ACA) eligibility.

**Medical social work** A form of social work practice that occurs in health care settings with the goal of assisting those who are physically ill, facilitating good health, and prevention of illness.

**Nursing** A field of practice versed in medical matters and entrusted with caring for the sick.

**Practice of social work** The application of social work knowledge, theories, methods, and skills to provide professionally sound, ethically bound, and culturally sensitive social services to individuals, groups, families, organizations, and communities.

**Psychology** The profession and science concerned with the behavior of humans, and related mental and physiological processes.

**Public health** Tasked with prevention of disease and maintenance of health in the population.

**Telemedicine** This avenue of delivery for patient care utilizes telecommunication technology to deliver patient care. This involves real-time interactive video capabilities.

#### **QUESTIONS FOR FURTHER STUDY**

- 1. In your own words, state several concrete differences between the services that nurses provide and social workers provide in the health care setting.
- 2. What do you believe can make health care social work practice an integral part of health care delivery?
- 3. What characteristic of social work practice makes it the most marketable in today's health care practice arena?
- 4. What do you see as the greatest obstacles to the use of telemedicine as opposed to traditional face-to-face approaches when serving patients/clients/consumers?
- 5. How do you believe health care social work will be defined in the future?
- 6. Taking into account what you have learned about team work, give an example of each type of team and where it could be utilized in health care practice today?

#### **ADDITIONAL ACTIVITIES**

#### **Activity One: Comparing Roles and Functions of Health Care Professionals**

Break the students down into groups and have them prepare a list outlining the basic roles of the nurse and that of the health care social worker. Be sure students are aware that they will be asked to share the list in class discussion.

In preparing the lists, have students identify the considerations that they feel are essential to address. Comment on the similarities found in the lists that each group creates.

#### Activity Two: Comparing Educational Backgrounds of Health Care Professionals

Similar to Activity One, break the students down into groups and have them prepare a list outlining the basic educational requirements of members of a traditional medical team, such as a physician, nurse, or social worker. Be sure students are aware that they will be asked to share the list in class discussion.

In preparing the lists, have students identify the considerations that they feel are essential to address. What about the educational background of these professionals makes them similar, and what makes them different?

### Activity Three: Health Care Social Workers, Empowering the Profession Through Education

Similar to Activity Two, break the students down into groups and have them prepare a list, taking into account the educational training of other core members of a health care delivery team. What basic ingredients are needed in the educational foundation of a health care social worker to make them stronger? What is needed to improve their status and knowledge when working with these other professionals and gaining their support? Should information provided always take into account the person-environment perspective? How can this be done? Be sure students are aware that they will be asked to share the list in class discussion.
