

Answer: Geography—community health problems can be directly influenced by latitude, altitude, and climate. For instance, parasitic and infectious diseases are a leading community health problem in tropical climates. Community size—the larger the community, the greater its range of health problems and the greater its number of health resources. Industrial development—may bring environmental pollution and occupational injuries and illnesses.
