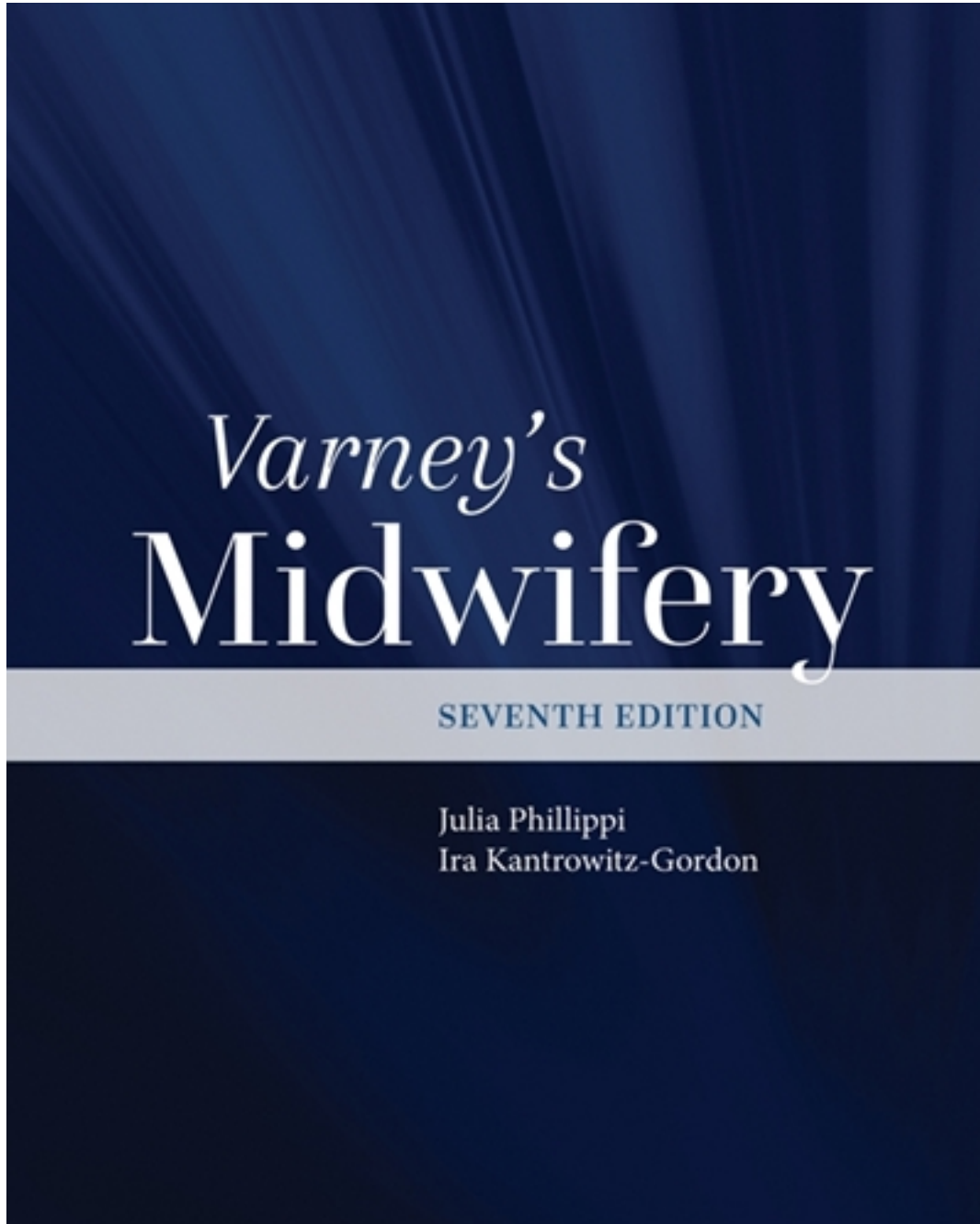

## CASE STUDY - CHAPTER 2

Kyra, a newly licensed certified nurse-midwife, advises Anne, who is 32 weeks pregnant, to have a pertussis vaccination during a regular prenatal visit. Anne's partner, Brandon, is also present. Kyra tells them that the vaccination is recommended by most maternity and pediatric care providers and that adverse reactions, such as allergy and fever, are possible but rare. She provides Anne with information on the frequency of these reactions. Kyra explains that it will help the baby develop immunity to a relatively common respiratory illness called pertussis and that this cannot be done by any other means until the baby is old enough to receive the vaccination at about 2 months of age. Anne says she does not want to have any vaccinations in pregnancy because she is worried about the effects of vaccine additives. Brandon says, "That's silly. We don't want the baby to get sick, do we?" Anne replies, "No, of course, I don't want that. I guess we can go ahead and do it." Kyra documents that Anne will accept the vaccination and continues with the visit.

## ANSWERS

1. B

The informed consent requires that an individual be competent, receive full information, comprehend the information, be free from coercion, and provide consent. Reviewing the possible risks and benefits of not receiving the vaccine enables Anne to give both informed consent and informed refusal. This reflects a higher ethical standard than informed consent alone.

2. C

To uphold the principle of autonomy, the midwife must respect a patient's right to make decisions regarding their care. Respect for privacy is an extension of this principle. Privately asking patients for permission to discuss their care in the presence of family members before doing so helps protect them from pressure or coercion and contributes to autonomous decision making.
