- 1. If someone commits a criminal act and claims that it was done at the direction of "voices in my head", what do you believe should be done by the criminal-justice system.
- a. The first issue which needs addressing is whether the criminal act is a violent one or in any other way presents an immediate danger or risk to the safety of the community and whether the perpetrator needs to be held in a confined environment. Then, the person should be evaluated by a mental health professional experienced in dealing with the criminal justice system, to determine several issues: are they malingering; prior mental health issues; are the "voices" constant, intermittent, or episodic; risk of violent behavior; is the condition treatable; are treatment resources available. After evaluation, the case must be presented to the court for adjudication and the decision made as to disposition.
