Describe how the definition of juvenile delinquency changes over time.

Suggested answer: Sample response: The definition of juvenile delinquency changes over time because who is considered a juvenile, and what is considered delinquent behavior, changes. As values differ over time and place, what is considered delinquent behavior may evolve into something more akin to childhood mischief, or may become more nefarious. Our laws determining juvenile status are still changing, and they differ from state to state.

Identify two status offenses and describe how they are similar or different in their perceived severity.

Suggested answer: Sample response: Neither running away nor underaged drinking would be considered crimes as an adult. While both would be considered status offenses, the statutory drinking age and the potential health dangers it poses place underaged drinking closer to delinquency on the spectrum of criminality than running away from home.

Discuss how juvenile delinquency is a normative conception.

Suggested answer: Sample response: Under a normative conception, juvenile delinquency is a violation of a set of expected behaviors established by a sort of social agreement.

Q61. [Essay]

Describe how the social constructionist perspective of delinquency is based on reactions to people in society.

Suggested answer: Sample response: In the social constructionist conception of delinquency, behaviors aren't inherently deviant. Rather, the label of deviance is attached to a group of behaviors once a set of rules have been created that then can be applied to cause those behaviors (and thus the group engaged in said behavior) to be considered deviant.

Suggested answer: Sample response: There seven key areas of well-being: family and social environment, economic circumstances, health care, physical environment and safety, behavior, education, and health.

Q63. [Essay]

Explain the difference between individual and institutional racism.

Suggested answer: Sample response: Individual racism is the belief in the inferiority of certain racial or ethnic groups, often accompanied by discrimination. It occurs in personal interactions. Institutional racism occurs when individuals are disadvantaged or oppressed because of their race because of the routine workings of social institutions such as the political system, the legal system, media, and education.

Q64. [Essay]

Define and discuss what juvenile delinquency is. Compare and contrast status offenses and delinquency offenses.

Suggested answer: Sample response: Juvenile delinquency is the violation of the penal code of an area by a person under the age of legal adulthood. This is in contrast to status offenses, which are violations of societal behaviors deemed inappropriate for underaged individuals. While delinquency is subject to official sanctions, due to the fact that they violate established laws, status offenses do not, and so are not subject to the same level of consequence.

Discuss the factors that contribute to and detract from the well-being of children.

Suggested answer: Sample response: The cradle-to-prison pipeline is a phenomenon that refers to the many issues that make it more likely that children will become incarcerated at some point in their lives. When there are unfavorable circumstances in important aspects of a child's life (pervasive poverty; inadequate access to health care coverage; gaps in early childhood development; disparate educational opportunities; intolerable abuse, neglect; unmet mental and emotional problems; substance abuse; overburdened, ineffective educational and juvenile justice systems), children are at greater risk of being involved in delinquency than they would be if the needs in the preceding circumstances were being met.

Compare and contrast individual racism and institutional racism in a juvenile delinquency context.

Suggested answer: Sample response: Individual racism occurs when individuals hold attitudes of prejudice based on race, and act on these attitudes in a discriminatory fashion. It can appear in forms such as stereotyping and bullying. Institutional racism occurs when a person's race leads to them being disadvantaged through the routine workings of institutions, rather than the direct prejudicial acts of an individual.

Suggested answer: Sample response: In a scenario where a 22-year-old young man is smoking cigarettes with his 17-year-old brother, the younger brother, due to being below the legal smoking age of 18, could be considered delinquent.

Q71. [Essay]

Describe the home environment of a youth who is most likely to engage in delinquency.

Suggested answer: Sample response: A youth who is most likely to commit a delinquent act lives in poverty and may experience home and food insecurity. If there is a home, it may be located in an area that has safety or environmental issues. Acting out of anxiety because of the circumstances could cause delinquent behavior.

Q72. [Essay]

Compare and contrast a situation where two youth are experiencing individual discrimination: one on the basis of race and the other one on the basis of gender. Which individual is more likely to be labeled as a delinquent?

Suggested answer: Sample response: A situation where two youths are being discriminated against can have differing experiences as a result of their race and gender. The youth who is being discriminated because of race will most likely be stereotyped and labeled a delinquent because there is a higher rate of race-based discrimination than there is gender discrimination.

Q73. [Essay]

Describe a situation in which a juvenile engages in a behavior that would normally be considered a status offense but the circumstances prevent it from being seen as such.

Suggested answer: Sample response: Under most circumstances, truancy is considered a status offense. However, if a child is forgoing school due to a temporary, family-approved situation, such as taking care of a sick relative, circumstances could prevent this truancy from being seen as a status offense.

Q74. [Essay]

Discuss the normative conception of delinquency. Include examples of folkways, mores, and laws.

Suggested answer: Sample response: The normative conception of delinquency assumes that there are a general set of norms upon which we agree. These consist of folkways, mores, and laws. Folkways are everyday norms that don't generate much uproar if violated. Mores are "moral" norms that elicit more outrage than folkways if violated, like picking your nose (folkway) versus drinking too much. Laws are backed by official sanctions and therefore are the norms that carry the greatest consequences of the three if violated.

Q75. [Essay]

Discuss the critical concept of delinquency and provide examples of how it may be applied.

Suggested answer: Sample response: The critical conception of delinquency argues that the normative understanding of deviance and delinquency is established by those in power to maintain and enhance that power. It focuses on a white, male, middle- to upper-class understanding of society that implies delinquency in groups outside of that privileged group. Such an environment could contribute to, for example, over-policing and an assumption of guilt as it pertains to individuals from poor communities of color.
