What is the similarity between Avicenna's "flying man" argument and Descartes' "I think, therefore I am" argument?

Suggested answer: Sample response: Both arguments rely on introspection and awareness of one's own thoughts to affirm the existence of the self. Both highlight the idea that awareness of the self (as the soul for Avicenna and as a thinking mind for Descartes) does not depend on the body, sensory experiences, or the physical world. This focus on self-awareness as the foundation of existence is the primary similarity between their ideas.

Briefly explain Averroes' contributions that are closely related to modern psychology.

Suggested answer: Sample response: Several of Averroes's ideas that were "firsts," but not all are closely related to modern psychological perspectives. The ideas that are relevant include his dream theory, which states that dreams are not supernatural but rather a random retelling of experiences and thoughts from the preceding day. Also influential today is his belief that humans are not entirely rational but instead are guided by emotions when making decisions. Averroes' idea of common sense, which integrates the separate impressions of the senses into the experiential whole, is what modern psychologists today refer to as multimodal perception.

What were the criticisms of Cartesian dualism?

Suggested answer: Sample response: One criticism is that the spiritual mind doesn't fit with Descartes' belief that humans are machines, but it is impossible to explain dualism without moving away from a mechanistic explanation. In addition, Descartes argues that the mind is in the soul, which means that animals, which he viewed as mindless machines, cannot have conscious experiences.

Explain Gottfried Leibniz's mill argument.

Suggested answer: Sample response: Leibniz imagines the human system of thinking as a giant machine, such as a mill, whose function is purely mechanical. He suggests that if we could walk inside this mechanical brain and observe its parts, we would see only mechanical processes—gears, levers, and motion—but we would not find anything that explains consciousness, sensations, or subjective experience. He claims that the material world lacks a mind, and that consciousness comes from the soul.

Why did Francis Bacon think induction was a better way of learning about the world than deduction?

Suggested answer: Sample response: Deduction uses syllogistic reasoning, which assumes that the premises we start with are true. Bacon questioned how scientists could know their initial premises are true unless they carefully observe the world. He suggested that we have to use a method of reasoning that examines specific cases in order to discover general rules. This is inductive reasoning, which allows scientists to collect many observations together to make a general statement about the world. Inductive reasoning prevents philosophers from using the art of deductive logic to “prove” their pet theories.

Explain what John Locke means by sensation and reflection.

Suggested answer: Sample response: Locke distinguished between outer senses and inner senses. Outer senses provide us with information about the outside world, and Locke used the term sensation to refer to these experiences. Inner senses tell us what’s happening inside our bodies and minds. Locke used the term reflection to refer to experiences brought into the mind by the inner senses.

Explain how simple ideas combine together to become complex ideas according to Locke.

Suggested answer: Sample response: Locke believed that the basic unit of thought is an idea, and that sensations and reflections make up simple ideas, which then combine to form complex ideas. When we pick up an apple and bite into it, we experience many sensations—redness, roundness, heaviness, crispness, sweetness, tartness. All of these simple ideas combine to create the complex idea of “apple.”

What are the three laws of association created by David Hume? Briefly explain each one.

Suggested answer: Sample response: Hume asserted that ideas are associated under the following circumstances: (1) resemblance, which is when two ideas are similar to one another; (2) contiguity, which is when two ideas occur at the same time or in the same space; (3) causation, which is when one idea comes directly after the other.

How does John Stuart Mill's compatibilism explain the existence of free will?

Suggested answer: Sample response: If nothing exists but a physical world, then all events have prior causes. Therefore, free will should be impossible. Mill argues that human free will can still exist even in a fully deterministic world. There are many reasons for any one of our decisions. If we can identify at least one other reason for why we did what we did, then we can say there is free will. This position is known as compatibilism.

What is the difference between rationalism and empiricism?

Suggested answer: Sample response: Rationalism argues that we learn about the world by using reason and logic. We can't rely on our senses because they aren't always accurate. Therefore, to learn about the world, we must rely on our mind. Empiricism argues that we learn about the world through observation. Empiricists also believe our senses can be deceiving, but they firmly believe that careful observation is the only way to know the world.

Explain Descartes' dualism and Hobbes' monism. Contrast their perspectives.

Suggested answer: Sample response: Descartes argued that the mind and body are separate entities that interact with one another. This is the definition of dualism. He believed the body is physical and takes in all sensory information, while the mind is spiritual—a unified conscious experience. Hobbes, on the other hand, was a materialist and argued that there is no separate essence for the mind. He argued that mental processes are mechanical, just as physical processes are. This is the definition of monism.

Compare Cartesian dualism and psychophysical parallelism.

Suggested answer: Sample response: Cartesian dualism assumes that the mind and body are separate entities but connect with one another in the pineal gland, where information from one can cross to the other. Psychophysical parallelism, on the other hand, states that the mind and body are separate entities that never interact, similar to the relationship between the physical and spiritual worlds. Something can happen that causes a reaction in both, but one does not cause the other.

How did George Berkeley's idealism reconcile science and religion?

Suggested answer: Sample response: George Berkeley was both a man of science and a man of deep religious faith. He believed that the world consists of two basic components: ideas and spirits. Ideas are passive entities that exist only as they are perceived. They depend on being perceived by a spirit. Spirits, on the other hand, are active, nonmaterial agents that perceive ideas. There are two types of spirits: humans and God. Berkeley reconciled science and religion by proposing that both are integrated within a unified view of reality. His approach centered on his belief that all reality is fundamentally mental and exists only as it is perceived by a mind, particularly the mind of God. This approach allowed Berkeley to address the materialist tendencies of science while maintaining his deeply religious worldview.

Compare Thomas Hobbes and George Berkeley's perspective on free will. Whose perspective better reflects how modern psychologists think about free will?

Suggested answer: Sample response: Hobbes argued for materialism, which is the idea that there is no separate substance that accounts for the existence of the mind. Therefore, the mind can be explained with the same mechanical laws that explain the body and the rest of the natural world. He believed people believe in free will because they do not understand the external reasons for their actions. Berkeley, on the other hand, rejected materialism and instead argued for idealism. In Berkeley's view, there is no matter to the world. Instead, what we perceive in the world comes from God's mind. Humans are active perceivers of God's world and can choose what they perceive and how they act on that information. Therefore, Berkeley's idealism argued for the existence of free will in humans. Hobbes' materialism is more in line with modern psychology, because modern psychologists believe we will ultimately discover all the explanations for why we think, feel, behave (etc.) the way we do.

Apply Hume's laws of association to explain how human beings might form stereotypes.

Suggested answer: Sample response: Hume's laws of association—resemblance, contiguity, and causation—can explain the formation of stereotypes. For example, resemblance plays a role when individuals associate members of a group with certain traits based on perceived similarity to others they've encountered. Contiguity reinforces stereotypes when individuals consistently observe certain behaviors in specific contexts or groups. Finally, causation is inferred by individuals when they mistakenly attribute behaviors to inherent qualities of a group rather than considering situational factors. These mental shortcuts, based on Hume's associative principles, help explain why stereotypes are pervasive and inaccurate.
