Explain the difference between race and ethnicity.

Suggested answer: Sample response: Race is a system of organizing people into groups perceived to be distinct because of physical appearance. Ethnicity comprises shared cultural norms, values, language, religion, geography, and nationality.

How is biology related to race?

Suggested answer: Sample response: Even though genes, such as skin color and hair, are associated with race, these differences are too small to fully represent a person’s race. Science indicates there are more biological differences between people in the same racial category than there are differences across racial categories.

How does failure to recognize the racial middle disproportionately harm racial categories other than Black and White?

Suggested answer: Sample response: The disproportionate focus on the supposed binary between White and Black racial categories makes invisible or dismisses other categories such as Latinx, Asian, and Native American as representational racial categories to be discussed in social inequities.

Suggested answer: Sample response: The best example to illustrate the flexibility of racial categories through time is to look at the U.S. Census bureau. For example, at one point, Native American people were not considered their own distinct category. This was based on their forced assimilation into White society.

Suggested answer: Sample response: Intersectionality refers to how the social categories, such as social class, gender, and race, are intimately connected and work in conjunction to reinforce advantages or disadvantages in society. This helps us see, for example, that all women's experiences are not the same and vary according to their other social positions such as race, citizenship status, or class.

Suggested answer: Sample response: There remains a lack of transnational women of color and research connecting the similarities in the struggles for equity. Therefore, a global inclusionary effort must be made to secure social equity for all women, regardless of their country of origin.

Suggested answer: Sample response: Colorblindness grew out of White people realizing overt prejudice was no longer socially acceptable. However, claiming one does not "see color" invalidates the very real experiences of oppression that people of color must deal with every day. Moreover, it does nothing to combat the existing structural mechanisms of oppression on which American was built. Colorblind racism is still racism.

Suggested answer: Sample response: Even if unnoticed or unintended to be negative, racial microaggressions can be harmful to the person who receives them because they emphasize "otherness." Furthermore, they perpetuate negative ideas, misinformation, and racial inequality.

Suggested answer: Sample response: Research indicates that children as young as 2 years old quickly understand that society favors one race over another, and that one race is preferred based on their interpretations of race-based meanings.

What are the differences between ethnicity and race?

Suggested answer: Sample response: Race refers to the socially constructed physical differences that a particular society considers important or unimportant. Physical characteristics act as visual markers, such as skin color, hair texture, the shape of a person's nose, the size and shape of one's head. However, race is intimately tied with social significance. It can become a social cue for inclusion in parts of society, such as affordable housing, job opportunities, health care, and educational attainment. When a physical characteristic becomes embedded with social significance, it becomes something that everyone agrees to because it seems natural or normal to believe it as truth, even though it is not valid. Ethnicity refers to the shared social and cultural norms, values, historical experiences, religion, and common languages that stem from common geographical backgrounds that make this subgroup unique. It is different from race precisely because ethnicity avoids the social construction of race as a biological determinant or visual cue of social difference that makes these two terms different.

How is the socially constructed idea of race connected to the U.S. system of enslavement?

Suggested answer: Sample response: To understand the connection between the social construction of race and its relationship to the United States, we must first look at power. Power is the ability to gain authority over individuals, groups, and other social institutions. To have power over someone or something means that it can or will maintain its dominance and influence on most if not all matters of social life. Given that most power and authority were obtained and maintained by White men, these men could construct a social idea, in this case, race. Race as a social construct is meant to describe or categorize society into various social groups based on skin color and other physical features deemed relevant. To be sure, it was not a valid biological concept; race is a social construction that gives or denies benefits and privileges to some while disadvantaging others. The United States developed and used the idea of race early to justify its new economic system of capitalism and colonial expansion. These two systems depended on the institution of forced servitude predominantly extracted from African peoples through enslavement. The method of slavery is one method in which White men could expand and maintain their power.

Suggested answer: Sample response: Race in U.S. society is seen as one that consists of Black and White racial groups. However, there is a gray area called the racial middle. The racial middle ground is where other racial groups become obscured or lost based on the misidentification that the United States has two primary racial groups. Viewing society through this lens dismisses several different identities, histories, and lived experiences. The racial middle becomes more critical when we look at social and racial inequities. For other marginalized racial groups to gain ground on being seen and heard when it comes to conversations of racial disparities in the United States, they assimilate into two categories: White or Black. However, by doing so, they also perpetuate the same system that forces them to assimilate to one or the other racial groups.

Suggested answer: Sample response: Intersectionality is a framework for conceptualizing a person, group of people, or social problem as affected by several advantages and disadvantages. Intersectionality considers an individual or group's overlapping identities and lived experiences to understand better the complexity of prejudices they face. Therefore, intersectionality allows us to see that social inequalities associated with disadvantages such as the lack of access to medical treatment, insurance, food, work, and an equal education stem from multiple sources of power that lead to oppression and exploitation connected to history. Social constructs such as race, class, sexual orientation, gender identity, religion, and ethnicity often overlap and do not exist independently. For example, while White women make 70 cents on the dollar compared to White men, the Black-White wage gap tells us something different. Black men make less than White men and slightly more than White women. However, Black women earn less than all categories.

Define racial colorblindness. Describe how colorblindness is harmful to people of color.

Suggested answer: *Sample response: In a racial context, colorblindness is a person's ability to proclaim that they do not "see color" and, under this same guise, only see humans. However, color is a socially constructed term that categorizes people in different racial groups. This occurs in ways that define who is superior and inferior. Race as a category associated with color is a pervasive and ongoing social issue that one cannot dismiss or generalize, as it has devastating and adverse effects on those deemed inferior. With that said, denying that one sees color as a racial category typically reproduces racial inequality; it is a covert method that perpetuates systems of social and racial disparities and denies that racial discrimination exists. Second, denying that racial color exists denies that person or persons the historical, cultural, and ethnic legacies they and past generations had to experience, thus rejecting their claim to historical cultural trauma. Lastly, denying a person's color is to deny them the opportunity to define and identify themselves within the social ecosystem.*
