Suggested answer: Sample response: Those with a constrained vision of human nature see human activities as constrained by an innate human nature that is self-centered and largely unalterable. Those with an unconstrained vision view human nature as being formed anew in each different culture and perceive human nature to be perfectible.

Suggested answer: Sample response: The classical school emphasized human rationality and free will in its explanations for criminal behavior.

Compare and contrast criminality and crime.

Suggested answer: Sample response: Crime and criminality sometimes mistakenly are used interchangeably. Crime is an intentional behavior that has been determined to be illegal or unlawful. Criminality is a scientific rather than legal term to refer to the characteristics of an individual that contribute to their willingness to engage in criminal behavior. So, a person's criminality could potentially lead to their participation in a legally defined crime.

Suggested answer: Sample response: A theory is a set of logically interconnected propositions explaining how phenomena are related and from which several hypotheses can be derived and tested. Theories help us make sense of seemingly unrelated facts and propositions.

Q72. [Essay]

Discuss the role of theory in criminology. What is a theory? What are the criteria for judging a theory? Do theories of crime provide the cause of criminal behavior?

Suggested answer: Sample response: A theory is an attempt to provide a logical explanation for something. This is not simply a guess or an opinion. A theory must be based on scientific properties to ensure it is credible and accurate. When we think about theories of crime, we attempt to explain why someone might engage in criminal behavior. And even when a theory is developed, we rarely will determine a "cause" to crime, but rather identify correlates or contributing factors to criminality.

Provide an overview of some of the major historical developments of criminological theory. Compare and contrast at least three of the main eras or schools of thought from the history of criminology.

Suggested answer: Sample response: Historically, beliefs about criminology have evolved and changed during different periods of time. Initially it was believed that crime was a result of demonic or supernatural beings. The Enlightenment brought about a new way of thinking in that individuals had free will to choose whether or not they participated in crime. The positive school approached crime from a scientific aspect. Thinkers during this time focused on the scientific process and although many practices were questionable, this paved the way for contemporary scientific examinations of crime.

Suggested answer: Sample response: *Mala in se* crimes are considered inherently bad, while *mala prohibita* refers to crimes that are time and culture bound. An example of a *mala in se* crime would be murder, while an example of a *mala prohibita* crime would be prostitution.

Discuss crime as a moving target. Are laws stable across time and culture? Provide a contemporary example of a law that has changed in recent years.

Suggested answer: Sample response: As society evolves so do the laws and legislation regulating behaviors of its citizens. Laws tend to vary across time as well as culture. What is acceptable in one culture might not be in another. Therefore the "definition" of crime is varied as well. An example of this is the recreational use of marijuana laws that we have seen passed in many states. What once was an illegal drug has been decriminalized in many states. However, when we look at federal statutes, marijuana is still considered an illegal drug.

Q79. [Essay]

Explain the continuum of harmful acts, and provide an example of each type of harmful act.

Suggested answer: Sample response: In defining harmful acts there are many different types and categories of seriousness. First, are socially harmful acts that need regulation but not by criminal law. This would include things like air pollution and healthcare standards. Private wrongs are those that are typically regulated by civil law. These would be things like reneging on a contract. Finally, there are socially harmful acts that need regulation by criminal law. An example of this would be burglary, rape, and murder.

Q80. [Essay]

Provide two examples of direct and indirect costs of crime.

Suggested answer: Sample response: Direct costs include costs of running the criminal justice system (salaries and benefits of personnel, and the maintenance costs of buildings and equipment) and the costs associated with each crime. Indirect costs include all manner of surveillance and security devices, protective devices (guns, alarms, security guards) and insurance costs, medical services, and the productivity and taxes lost of incarcerated individuals.
