Q41. [Essay] · Cognitive Domain: Application

Based on what you’ve learned so far in this course, share your ideas about how to avoid replicating racial and economic inequality in using assessment tools for decisions related to school admissions and placement.

Suggested answer: Sample response: The response would discuss evident differences between school system funding and how it related to available resources. The range of possible solutions could include broad government/community programs to distribute resources equitably, to offering additional support for educational interventions through charitable donations, fundraising, or volunteer engagement. The response should also describe continuing efforts to base assessment on diverse norm groups and review tests for assumptions based on bias, language issues, and so on.

Q42. [Essay] · Cognitive Domain: Application

Do you think it is possible to make school admissions and placement decisions without using the assessment tools described in this chapter? Why or why not? If so, give an example of how a placement/admission decision could be made without using a test. If not, share a suggestion on how assessment can be made bias-free.

Suggested answer: Sample response: Good quality responses could address how many other aspects (besides testing) of a prospective student's work (academic and non-academic) could be used, admission committees could be consciously made more racially and ethnically diverse, and so on. Responses stating that tests are necessary should address the steps that can be taken to improve test development toward culture-fairness.

Q43. [Essay] · Cognitive Domain: Analysis

Three perspectives for the study of African American psychology are described in the chapter, universal, African, and convergent. Based on your own experience, share which perspective you believe is more appropriate for its study.

Suggested answer: Sample response: A good quality response can take any of the three positions offered and should present an example of how a universal principle applies to people from different groups, or an African principle worked better for a person of color than a Western one, or provide examples of both cases (for the convergent perspective).

Q44. [Essay] · Cognitive Domain: Application

Recount a time when you or someone you know well confronted a possibly biased assessment procedure. How could this procedure have been made more fair and objective?

Suggested answer: Sample response: A good quality response could describe an incident of finding a question or a task included in an assessment procedure that would provide a nature advantage to an individual from a specific group, or an incident where members of a specific group were given special treatment or discriminated against. Answers will vary widely.

Q45. [Essay] · Cognitive Domain: Application

Describe an experience you have had as a student when confronting or being introduced to members of a group with whom you were not familiar changed your perspective on what constitutes "typical" or expected behavior. Compare your point of view on this behavior or custom before and after exposure to it.

Suggested answer: Sample response: A good quality response could describe encountering a situation where emotions were handled in an unfamiliar way (restrained when it seemed they should be expressed, or expressed when they might have been restrained, where fictive kin were treated as blood relatives, etc.) Answers will vary widely.

Define and describe the universal and African perspectives on psychology. How does the convergent perspective reconcile and synthesize these frameworks?

Suggested answer: Sample response: Sample answer here, or at least key points that a good answer should cover.

Identify a concept introduced in this chapter that applies to African Americans and members of other groups. Describe how it would apply to Black individuals and members of at least one other specific group.

Suggested answer: Sample response: Many examples are possible.

Q48. [Essay] · Cognitive Domain: Analysis

Compare two frameworks for understanding Black psychology that were presented by two different African-American psychologists. Discuss their similarities and differences.

Suggested answer: Sample response: Some of the frameworks that could be discussed and compared include those of Joseph White, Kambon (J.A. Baldwin), Azibo, Fairchild, and other psychologists whose work is described in the chapter.

Q49. [Essay] · Cognitive Domain: Comprehension

Define the term self-determination with reference to African American psychology. Provide an example of how the evolution of African American psychology has also included one or more steps toward self-determination.

Suggested answer: Sample response: Some examples of self-determination through the evolution of African American psychology include the establishment of the ABPsi, the research that questioned eugenics and other scientific racism, research that focuses on within group differences, resilience, and other positive aspects of functioning. Answers will vary widely.

Q50. [Essay] · Cognitive Domain: Analysis

Describe a study using non-experimental research techniques that could be used to better understand African-American behavior and experiences. Include information about its strengths and weaknesses and what you anticipate its conclusions would be.

Suggested answer: Sample response: A good quality response should discuss the use of a naturalistic or other type of observation, or an interview-based study. The lack of experimental control could be contrasted with the possibility of obtaining a perspective on the self-knowledge of research participants.
