CHAPTER OUTLINE

I. What Is Sociology?

- i. Sociology is the study of human behavior in society. Sociologists are interested in the study of people and have learned a fundamental lesson: human behavior, even when seemingly “natural” or taken for granted, is shaped by social structures—structures that have their origins beyond the immediately visible behaviors of everyday life.
- ii. Sociology is a scientific way of thinking about society and its influence on human groups. Observation, reasoning, and logical analysis are the tools of sociologists.
- iii. Sociologists often appear in the media, and they study some of the same subjects that the media examine, such as crime, violence, immigration, or income inequality, but sociologists use specific research techniques and well-tested theories to explain social issues.
- iv. The subject matter of sociology is everywhere. This is why people sometimes wrongly believe that sociology explains just the obvious.
- v. How is sociology different from psychology? Both study people, and both identify some of the social forces that shape our lives. There is, however, a difference.

II. The Sociological Perspective

- i. The beginnings of the sociological perspective can be as simple as the pleasures of watching people or wondering how society influences people’s lives.
- ii. C. Wright Mills (1916–1962) was one of the first to write about the sociological perspective in his classic book, *The Sociological Imagination* (1959). He defined the *sociological imagination* as the ability to see the societal patterns that influence individuals as well as groups and whole societies.
- iii. The sociological imagination distinguishes between *troubles* and *issues*.
 - (1) Troubles are privately felt problems that spring from events or feelings in a person’s life.
 - (2) Issues affect large numbers of people and have their origins in the institutional arrangements and history of a society.

- iv. *Individualism* is an ideal that values each person's life and self-worth. Deeply tied to values of individual freedom and rights, individualism is a core tenet of American democracy.
 - v. Sociologists see social structures through careful and systematic observation. This makes sociology an empirical discipline. *Empirical* refers to careful observation, not just conjecture or opinion.
 - a. Discovering Unsettling Facts
 - i. In studying sociology, it is crucial to examine the most controversial topics and to do so with an open mind, even when you find the most disquieting facts.
 - b. Debunking in Sociology
 - i. Debunking refers to looking behind the facades of everyday life—what Berger called the “unmasking tendency” of sociology.
 - ii. Debunking is sometimes easier when looking at a culture or society different from one's own. Consider how behaviors that are unquestioned in one society may seem positively bizarre to an outsider.
 - c. Establishing Critical Distance
 - i. Debunking requires critical distance—that is, being able to detach from the situation at hand and view things with a critical mind. The role of critical distance in developing a sociological imagination is well-explained by the early sociologist Georg Simmel (1858–1918). Simmel was especially interested in the role of strangers in social groups.
- III. The Significance of Diversity
- i. The analysis of diversity is a central theme of sociology. Differences among groups, especially differences in the treatment of groups, are significant in any society, but they are particularly compelling in a society as diverse as that in the United States.
 - a. Defining Diversity
 - i. Today, the United States includes people from all nations and races. In 1900, one in eight Americans was not White; today, racial and ethnic minority groups (including African Americans, Hispanics, Native Hawaiians and people from other Indigenous groups, Asian Americans, and people of more than one race) represent 22 percent of people in the United States. That proportion is growing (U.S. Census Bureau 2023).
 - ii. The term *diversity* refers to the variety of group experiences that result from the social structure of society. Diversity is a broad concept that includes studying group differences in society's opportunities, the shaping of social institutions by different social factors, the formation of group and individual identity, and the process of social change.

- iii. Sources of diversity include race, class, gender, and others. Age, nationality, sexual orientation, and region of residence, among other factors, also differentiate the experiences of diverse groups in the United States.
- b. Society in Global Perspective
 - i. The social and economic system of any one society is increasingly intertwined with those of other nations.
 - ii. Comparing and contrasting societies across different cultures is valuable.
 - iii. A global perspective, however, goes beyond just comparing different cultures. A global perspective also helps you see how events in one society or community may be linked to events occurring on the other side of the world.
- IV. The Development of Sociological Theory
 - a. The Influence of the Enlightenment
 - i. Also known as the Age of Reason, the Enlightenment was characterized by faith in the ability of human reason to solve society's problems.
 - ii. Auguste Comte (1798–1857), a French philosopher who coined the term *sociology*, believed that just as science had discovered the laws of nature, sociology could discover the laws of human social behavior and thus help solve society's problems. This approach is called *positivism*, a system of thought still prominent today, in which scientific observation and description are considered the highest form of knowledge, as opposed to, say, religious dogma or poetic inspiration.
 - iii. Alexis de Tocqueville (1805–1859), a French citizen, traveled to the United States as an observer beginning in 1831. Tocqueville thought that democratic values and the belief in human equality positively influenced American social institutions and transformed personal relationships.
 - iv. Another early sociologist was Harriet Martineau (1802–1876). Like Tocqueville, Martineau, a British citizen, embarked on a long tour of the United States in 1834. She was fascinated by the newly emerging culture in the United States.
 - b. Classical Sociological Theory
 - i. The giants of the European tradition were Emile Durkheim (France), Karl Marx (Germany), and Max Weber (Germany).
 - a) Emile Durkheim
 - (i) During Emile Durkheim's early academic career (1858–1917), France was experiencing great political and religious upheaval.
 - (ii) Durkheim also viewed society as an entity larger than the sum of its parts. He described this as

society *sui generis* (which translates as “thing in itself”), meaning that society is a subject to be studied separately from the sum of the individuals who compose it.

- (iii) Durkheim created the term *social facts* to indicate those social patterns that are external to individuals.

b) Karl Marx

- (i) Marx thought that the economic organization of society was the most important influence on what humans think and how they behave.
- (ii) Marx considered all of society to be shaped by economic forces. Laws, family structures, schools, and other institutions all develop, according to Marx, to suit economic needs under capitalism.

c) Max Weber

- (i) Max Weber was greatly influenced by and built upon Marx’s work.
- (ii) Weber theorized that society had three basic dimensions: political, economic, and cultural. According to Weber, a complete sociological analysis must recognize the interplay between economic, political, and cultural institutions.
- (iii) Weber professed that the task of sociologists is to teach students the uncomfortable truth about the world.
- (iv) An important concept in Weber’s sociology is *verstehen*. It is a German word that refers to understanding social behavior from the point of view of those engaged in it. Weber believed that to understand social behavior, one had to understand the meaning that a behavior had for people.

c. Sociology in the United States

- i. W. E. B. DuBois was one of the most important early sociological thinkers in the United States.

- a) The significance of his work is only now being re-discovered and integrated into the history of sociological thought.
- b) DuBois was deeply troubled by the racial divisiveness in society, writing in a classic essay published in 1901 that “the problem of the twentieth century is the problem of the color line.”

- c) Much of DuBois's work focused on the social structure of Black communities, with one of his classic studies being of the city of Philadelphia. His book, *The Philadelphia Negro*, published in 1899, remains a classic study of African American urban life and its social institutions. One of the most lasting ideas from DuBois is his concept of "dual (or double) consciousness."
- ii. Robert Park (1864–1944), from the University of Chicago, was a key founder of sociology. Originally a journalist who worked in several Midwestern cities, Park was interested in urban problems and how different racial groups interacted with each other.
- iii. Jane Addams (1860–1935) was one of the most renowned sociologists of her day. She was the only practicing sociologist ever to win a Nobel Peace Prize (in 1931), yet she never had a regular teaching job. She was a leader in the settlement house movement, providing services and doing research to improve the lives of those who lived in slum housing, immigrants, and other people with low economic status.
- iv. Ida B. Wells-Barnett (1862–1931) is now well-known for her brave campaign against the lynching of African American people. Less known are her early contributions to sociological thought.

V. Theoretical Frameworks in Sociology

a. Functionalism

- i. The functionalist framework emphasizes the consensus and order that exist in society, focusing on social stability and shared public values. From a functionalist perspective, disorganization in the system, such as an economic collapse, leads to change because societal components must adjust to achieve stability.

b. Conflict Theory

- i. Conflict theory emphasizes the role of coercion and power in society and the ability of some to influence and control others.
- ii. Conflict theory pictures society as comprised of groups that compete for social and economic resources. Social order is maintained not by consensus but by domination, with power in the hands of those with the greatest political, economic, and social resources.
- iii. According to conflict theory, inequality exists because those in control of a disproportionate share of society's resources actively defend their advantages.
- iv. Conflict theorists see inequality as inherently unfair. They believe it persists only because economically advantaged groups use their social position to their own advantage.

- v. Conflict theory has been criticized for neglecting the importance of shared values and public consensus in society while overemphasizing inequality.
- c. Symbolic Interaction
 - i. Symbolic interaction theory emphasizes immediate social interaction as the place where “society” exists.
 - ii. Derived from the work of the Chicago School, symbolic interaction theory analyzes society by addressing the subjective meanings that people impose on objects, events, and behaviors. Subjective meanings are important because, according to symbolic interaction, people behave based on what they believe, not just what is objectively true.
 - iii. Symbolic interaction interprets social order as constantly negotiated and created through the interpretations people give to their behavior.
- d. Feminist Theory
 - i. Contemporary sociological theory has been greatly influenced by the development of feminist theory.
 - ii. Feminist theory developed to understand women’s status in society and to use that knowledge to better women’s lives.
 - iii. Feminist theory has created vital new knowledge about women and has also transformed what is understood about men.
 - iv. Feminist theory takes gender as a primary lens through which to view society.
 - v. Feminist theory is now a vibrant and rich perspective in sociology. It has greatly enhanced people’s understanding of the sociology of gender and its connection to other social factors, such as race, sexuality, age, and class.

2. **Jane Addams** Have your students discuss the sociology of Jane Addams. In the discussion, have them debate the role of the field in solving social problems. Have them answer the question of whether a sociologist should be doing work related to social change.

3. **Debunking:** Imagine you're a sociologist tasked with debunking a common belief about school, family, or work. What hidden patterns or inequalities might you uncover? Share examples from your own experiences or observations and discuss how they challenge what people usually assume.
4. **Enlightenment:** The Enlightenment emphasized reason, science, and discovery as tools for solving society's problems. How do you think this faith in human reason and scientific observation continues to shape the way we approach social issues today? Can you think of examples where science has successfully addressed societal challenges—or where it has faced limitations?
5. **Comparing Sociological Theories:** Which perspective (functionalism, conflict theory, symbolic interaction, and feminist theory) do you think is most effective in addressing issues of inequality, and why? Can you think of a real-world example where one of these theories offers the best explanation for a societal phenomenon?

ADDITIONAL ACTIVITIES AND ASSIGNMENTS

The following are activities and assignments developed by Cengage but are not included in the text, PPTs, or courseware – they are for you to use if you wish.

1. **See For Yourself Troubles and Issues.** Assign an exercise on “Troubles and Issues” using key concepts presented in this chapter, including debunking, diversity, the research process, and so on. Have students write about or discuss the differences between troubles and issues.
2. **Diversity** Divide students into small groups to examine their own diversity using the broad understanding of diversity presented in this chapter. Have them compare themselves to the emerging patterns of diversity in the United States and reflect on how they can prepare themselves to live with that diversity and to relate to it as developing sociologists. This would be a good time to introduce students to the *U.S. Census Bureau* (www.census.gov). If the class is small, conduct the exercise for the whole class.
3. **Theoretical Perspectives** To ensure that students understand the major sociological perspectives, present them with an issue of contemporary concern—like homelessness—and have them describe how they think functionalists, conflict theorists, symbolic interactionists, and feminists would approach the issue. This could be conducted as an in-class exercise or assigned as a take-home paper and discussed later. In addition to exploring the approaches of the major theoretical perspectives, this exercise could also be organized by social location. Student groups could be assigned to represent diverse social classes, race/ethnicity, and gender perspectives.

4. **Classic Sociologists.** Using [SocioWeb](#), have students select a classic sociologist who interests them (click on the “Giants of Sociology” link) and write a brief essay on the sociologist’s contributions to the field.
5. **Taking Action on Social Issues** Students often want to know how they can get involved with improving social conditions. Have them visit the website <https://uspirg.org> and research a particular issue along with the actions being taken to deal with it, and write a short paper or present to the class about the topic.

The Social Dilemma (2020, 94 min): This documentary reveals the profound human impact of social media, featuring insights from tech experts who critique the manipulative designs of their own platforms, sparking discussions on ethics, addiction, and societal consequences

Who We Are: A Chronicle of Racism in America (2021, 117 min): This documentary combines personal stories, historical analysis, and interviews to trace the roots and ongoing impact of anti-Black racism in the United States, offering a sobering look at systemic injustice and inequality.

This Place Rules (2022, 82 min): Exploring the societal tensions that led to the January 6 Capitol riot, this documentary examines media influence, political polarization, and cultural undercurrents shaping a divided America in the lead-up to the event.

Addams, Jane. 1930. *The Second Twenty Years at Hull-House: September 1909 to September 1929*. New York: Macmillan. This book looks at the impact of Hull House on the community. It is a good reference book for understanding how research and activism, when sustained, can lead to social change.

Berger, Peter L. 1963. *Invitation to Sociology: A Humanistic Perspective*. New York: Anchor. In this classic introduction to the discipline, Berger emphasizes how sociology can help debunk erroneous assumptions about human behavior and demystify the workings of the social world.

Best, Joel. 2001. *Damned Lies and Statistics: Untangling Numbers from the Media, Politicians, and Activists*. Berkeley: University of California. Best describes basic social statistics and how they are used and abused by media, politicians, and activists, through a systematic and enjoyable exploration of examples and issues.

Dolgon, Corey, and Chris Baker. 2010. *Social Problems: A Service Learning Approach*. Thousand Oaks, CA: Sage. This book offers a helpful overview of the use of sociology in solving social problems. The approach taken to social problems helps students understand how these can be addressed by using the tools of the social sciences.

Lemert, Charles. 2006. *Social Things: An Introduction to the Sociological Life*. Third edition. Lanham, MD: Rowman & Littlefield. This personal sociological journey illustrates the sociological imagination in action and clearly demonstrates the promise of sociological theory and research.

Zinn, Howard. 1980 (1995). *A People's History of the United States: 1492–Present*. Revised Edition. New York: Harper Perennial. This classic, based on oral history and documentary analyses, presents a side of history ignored or misrepresented in standard accounts or official sources.
