Postmodern perspectives: The sociological approach that attempts to explain social life in contemporary societies that are characterized by postindustrialization, consumerism, and global communication.

Social Darwinism: Herbert Spencer's belief that those species of animals, including human beings, best adapted to their environment survive and prosper, whereas those poorly adapted die out.

Social facts: Emile Durkheim's term for patterned ways of acting, thinking and feeling that exist outside any one individual but that exert social control over each person.

Society: A large social grouping that shares the same geographical territory and is subject to the same political authority and dominant cultural expectations.

Sociological imagination: C. Wright Mills' term for the ability to see the relationship between individual experiences and the larger society.

Sociology: The systematic study of human society and social interaction.

Symbolic interactionist perspectives: The sociological approach that views society as the sum of the interactions of individuals and groups.

Theory: A set of logically interrelated statements that attempts to describe, explain, and (occasionally) predict social events.

Urbanization: The process by which an increasing proportion of a population lives in cities rather than in rural areas.

ADDITIONAL DISCUSSION QUESTIONS

The following are discussion questions that do not appear in the text, PPTs, or courseware – they are for you to use as you wish. You can assign these questions several ways: in a discussion forum in your LMS; as whole-class discussions in person; or as a partner or group activity in class.

1. **Discussion: Sociological Imagination, Duration 15 minutes.**
 - a. What is the sociological imagination?
 - i. Answer: C. Wright Mills' term for the ability to see the relationship between individual experiences and the larger society.
 - b. How might the sociological imagination be useful in your everyday life?
 - i. Answer: Answers will vary. Students should consider the difference between "personal problems" and "public issues" or the difference between "blaming the victim" and "blaming the system."
2. **Discussion: Unemployment as a Public Issue, Duration 15 minutes.**
 - a. Why can the ability to secure a job be affected by factors at the individual level?
 - i. Answer: The ability to secure a job may be affected by several factors that we may perceive are at the individual level, including making the effort to locate open jobs, having the social networks (through tools like LinkedIn) to connect with available positions, having the ability to interview for the position (transportation, technology, and position-appropriate attire), and possessing the credentials, skills, or other qualifications (such as degree) required for the position.

- b. How did the COVID-19 pandemic influence the unemployment rate?
 - i. Answer: A very striking example was the increase in the unemployment rate during the early months of the COVID-19 pandemic. This increase was the result of the closing of businesses, including those in the service (restaurants) and entertainment (theaters) industries, and the shifting to online learning for schools and working remotely for many places of business, which reduced the availability and need for childcare.

 - i. Answer: Provide students with an intellectual framework, imparting practical skills, and conveying society's values.

 - i. Answer: A feminist theoretical approach directs attention to women's experiences and the importance of gender as an element of social structure.
 - b. What system do feminist theorists believe we live in?
 - i. Answer: According to feminist theorists, we live in a patriarchy, a system in which men dominate women and people of other genders.

ADDITIONAL ACTIVITIES AND ASSIGNMENTS

The following are activities and assignments developed by Cengage but are not included in the text, PPTs, or courseware – they are for you to use if you wish.

1. **The Sociological Imagination:** Surf news sources on the Internet in class and use some of these as a springboard for your presentation of C. Wright Mills' ideas about the **sociological imagination**.

- a. Find stories that seem to relate news about personal problems, such as family, crime, employment, health, and education.
 - b. You may have to help your students work backward to determine how these stories reflect personal troubles.
 - c. What are the social issues involved? Challenge your class to engage in big-picture thinking.
2. **Theoretical Thinking:** Introduce theoretical thinking by asking your students to come up with some of their own theories about “why things are the way they are.” You will need to help them refine their thinking; this is a great way to introduce some of the key ideas of the thinkers in this chapter. Keep asking “why?” to students’ theoretical explanations. This will help push students into more general and abstract thinking. Provide an example to get everyone started:
 - a. Why is health care such a social problem?
 - b. Why do families come apart?
 - c. Why are some people better prepared for the future?
3. **The American Sociological Association:** To get a better grip on what sociology is all about, ask students to explore the American Sociological Association’s website. Students can explore the three major sections on the main page: (sociologists, students, and the public). Students should bring to class a piece of information that they discover while exploring this site.

VIDEO SUGGESTIONS

- **Selma** (128 minutes)
Selma is the story of a movement. The film chronicles the tumultuous 3-month period in 1965 when Dr. Martin Luther King, Jr. led a dangerous campaign to secure equal voting rights in the face of violent opposition. The epic march from Selma to Montgomery culminated in President Johnson signing the Voting Rights Act of 1965, one of the most significant victories for the civil rights movement. Selma tells the real story of how the revered leader and visionary Dr. Martin Luther King Jr. and his brothers and sisters in the movement prompted change that forever altered history.
- **Nicholas Christakis: The Sociological Science Behind Social Networks and Social Influence** (56 minutes; YouTube)
Description from SocCinema: In this nice introductory lecture on the discipline of sociology, physician and sociologist Nicholas Christakis explodes the popular myth that people are masters of their own destiny. As the YouTube blurb states, “If you think you’re in complete control of your destiny or even your own actions, you’re wrong. Every choice you make, every behavior you exhibit, and even every desire you have finds its roots in the social universe.”

- **Advertising & The End of the World** (46 minutes)
Drawing from the broad arena of commercial imagery, and utilizing sophisticated graphics, *Advertising & The End of the World* addresses the issues these questions raise, encouraging viewers to reflect on their own participation in the culture of consumption. Making the connection between society's high-consumption lifestyle and the coming environmental crisis, Jhally forces us to evaluate the physical and material costs of the consumer society and how long we can maintain our present level of production.
- **The Persuaders** (90 minutes; PBS Frontline)
Frontline examines the "persuasion industries"—advertising and public relations. To cut through consumers' growing resistance to their pitches, marketers have developed new ways of integrating their messages into the fabric of our lives, using sophisticated market research techniques to better understand consumers, and turning to the less-understood techniques of public relations to make sure their messages come from sources we trust.
- **Greed: Is It Necessarily Bad?** (90 minutes; Films for the Humanities and Sciences)
Discusses the subject of credit cards and consumerism. Show this film to ensure a lively discussion. In a material world, some argue that financier Michael Milken may have done more for humanity than even Mother Teresa. In this program, ABC News anchor John Stossel, entrepreneur Ted Turner, economist Walter Williams, and philosopher David Kelley redefine greed, discussing its value as the driving power in business that creates opportunities for others as it churns wealth for itself, by pumping capital into the economy, providing jobs, and offering goods and services that improve the quality of life. Greed may be the best thing to come along since philanthropy.
- **The Card Game** (90 minutes; Frontline)
As credit card companies face rising public anger, new regulation from Washington and staggering new rates of default and bankruptcy, *Frontline* correspondent Lowell Bergman investigates the future of the massive consumer loan industry and its impact on a fragile national economy. In *The Card Game*, a follow-up to the *Secret History of the Credit Card* and a joint project with *The New York Times*, Bergman and the *Times* talk to industry insiders, lobbyists, politicians, and consumer advocates as they square off over attempts to reform the way the industry has done business for decades.
- **The Suicide Plan** (83 minutes; Frontline)
This Frontline film explores the underground world of assisted suicide from the point of view of not only those choosing to die but also those people and organizations that assist them.
- **A Death of One's Own** (88 minutes; Films for the Humanities and Sciences)
This film addresses issues related to personal control and physician-assisted suicide. Bill Moyers hosts interviews with three families and their doctors.

- **Juliet Schor, *The Overspent American*** (33 minutes)
In this powerful video, Juliet Schor scrutinizes what she calls “the new consumerism”—a national phenomenon of upscale spending that is shaped and reinforced by a commercially driven media system. She argues that “keeping up with the Joneses” is no longer enough for middle- and upper-middle-class Americans, many of whom become burdened with debilitating debt as they seek to emulate materialistic TV lifestyles.
- **Karl Marx and Marxism** (53 minutes; Films for the Humanities and Sciences)
This program looks at Marx, at the roots of his philosophy, at the causes and explanations of his philosophical development, and at the most direct outcome of his philosophy: the failed Soviet Union.
- **Gosford Park** (138 minutes; Netflix)
This is a great film that demonstrates the stark class distinctions that persist in other parts of the world. The film will help students understand the kind of world that Marx was addressing as he developed his grand theory. There are several excellent clips you can discuss with students; or you can assign the film for extra credit. Watch it yourself before your presentation about social theories.
- **Guns, Germs, and Steel** (180 minutes; National Geographic Video)
Showing clips from this video, which is based on the bestselling book by the biologist Jared Diamond, can help you explain social evolution (Spencer) and the impact of industrialization and urbanization on the development of world civilizations. Your university library may have this DVD in its collection, or you can find it on Netflix.
- **Les Misérables** (159 minutes)
Show the whole film or just excerpts to capture the mood of the Industrial Revolution across Europe. This film helps you show students the historical context of thinkers like Comte, Marx, and Spencer.
